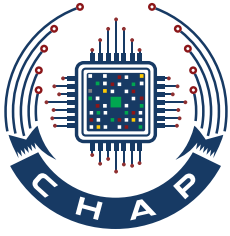

INSTRUCTIONS FOR MEMBERSHIP

Membership Period: (One year: April 01 to March 31 each year)

The Computer Hardware Association of Pakistan (CHAP) entertains those applications for Membership whose Head Office, Registered Office, or Branch Office is located within the jurisdiction of the Islamabad Capital Territory (ICT) or any designated area approved by the Association.

Corporate Member (CM)

Membership Period: (One year: April 01 to March 31 each year) The Computer Hardware Association of Pakistan (CHAP) entertains those applications for Membership whose Head Office, Registered Office, or Branch Office is located within the jurisdiction of the Islamabad Capital Territory (ICT) or any designated area approved by the Association.

Associate Member (AM)

A member of CHAP which is either a body corporate, a multinational corporation with its head office or branch office in Pakistan, or a sales tax registered manufacturing/business concern having an annual turnover of Rs. 50 million or above shall be classified as a Corporate Member.

Associate Member (AM)

A member of CHAP which is not a body corporate or multinational, or not a sales tax registered manufacturing/business concern having annual turnover of Rs. 50 million or above, shall be classified as an Associate Member.

Membership Granting Rules

Membership shall be granted strictly in light of the above-mentioned criteria and there shall be no discretion to choose the membership class by the prospective applicant. Where required, a physical survey of the business address may be carried out for verification purposes.

For Membership

- 1 A copy of CNIC/ Passport of Proprietor (in case of foreign national)
- 2 a) A copy of National Tax Number (NTN) certificate on the name of business
b) Latest Income Tax Return where applicable, on the name of Proprietor
- 3 A copy of Sales Tax Registration and latest Sales Tax Return, if registered / applicable
- 4 Three photographs of the proprietor (one for pasting on the application form & two for IDC)
- 5 Lease deed / allotment letter of the premises / office as a proof of business on the indicated address
- 6 Original bank certificate on the name of business
- 7 It must be a computer-related activity on NTN and filed.
